Sub: Re-establishment of **Internal Quality Assurance Cell(IQAC)** -Orders Issued-Regarding

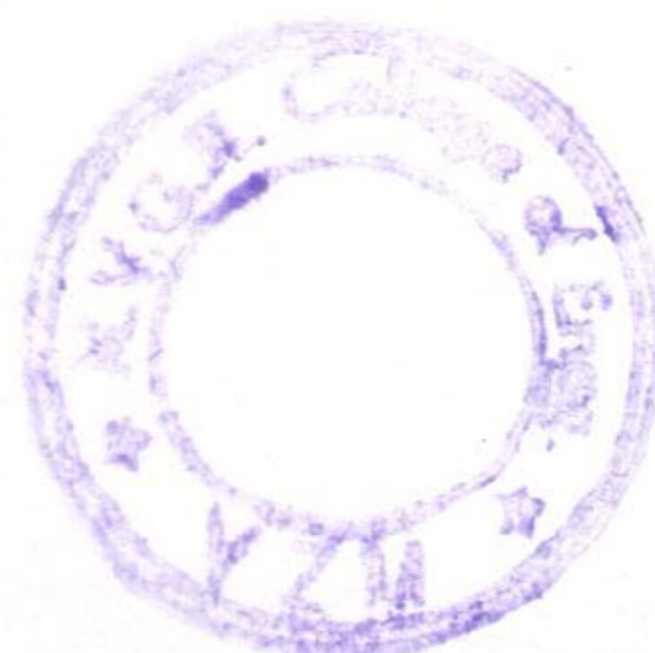
